1. Call the meeting to order.

Discussion: Supervisor Brilowski asked about the Zblewski invoice for \$1,000 for the removal of a tree on the Tom and Heidi O'Brien property. Will the O'Briens be responsible for all or some of the cost of the removal since the tree was on their property?

Supervisor Lipski: The O'Briens were not home. They were on vacation abroad and could not be reached. There was a safety concern. Zblewski's could have removed part of the overhang/tree but had a liability concern. It was decided by Chairperson Wilz, Supervisor Lipski with input from Zblewski's, in the interest of safety to remove it.

Supervisor Brilowski: So the question remains, will the O'Briens be responsible for all or part of the tree removal.

11. <u>Determination of timing of Solar installation</u>.

Supervisor Way: At the Annual Meeting we were given permission to pursue this project. Dave asked to search out another bid. This was done but the vendor declined as they did not have time to do the project and did not want to offer a bid. It was decided to continue discussion with North Wind Solar. North Wind Solar is willing to work with Hull as we continue to search out funding. It was determined we need flexibility as when we want to do the project and when we pay for it.

Supervisor Way made a motion to move forward with the solar project and give the Chairperson the authority to work with North Wind Solar for installation in 2024.
