I propose we make the following changes:

- 1. River Cities--close the Money Market and Business Savings accounts. Transfer \$557,464 to open a 24 month CD which pays 2.5% interest
- 2. Investors Bank--keep the Money Market account open with the balance of \$406,370.
- 3. Chase Bank-- transfer \$200,000 from General Business Savings to Associated Bank CD; keep any remaining daily working balances in Chase Checking and General Savings.
- 4. Associated Bank—open new 12 month CD for \$200,000 paying 2.35% interest.

Interest we earned in 2018 totaled \$14,358. If the interest rates remain fixed at current levels we could expect to earn \$28,758 in 2019, an increase of \$14,400.

Jim reviewed his proposal as presented adding the following:

- As of today the money market interest rate at Investors Bank has increased to 2.47%
- Would like to eliminate opening an account at Associated Bank and deposit an additional \$200,000 in the Money Market account at Investors Bank
- Have no fees associated with the accounts at Chase, however have to maintain a balance of \$100,000
- Chase provides Hull with additional collateralization during the months of December, January and February when tax deposits are being made – recently we had over 3 million in our tax account (also the reason the interest rate Hull receives is low)
- When first started as treasurer made lengthy proposal to the board to move funds from Chase. No action was taken.

D Wilz:

- Do not have problem changing banks but wonder why we would
- Need to have 3 banks to make sure our funds are covered by insurance (FDIC and State)
- > When interest earned on designated reserves, where does the interest go

J Kruziki – to the reserve account where it was earned

Motion Supervisor Wilz, <u>approve Treasurer Kruziki Investment Plan with the change made verbally at the meeting. Update the plan sheet accordingly</u>

<u>and provide a copy to Clerk Wolle</u>. Second by Supervisor Way. Motion carried by voice vote.

05. Compost Site Options for 2019 for Review, Discussion and Possible Action – Dave Wilz, Supervisor

Patty Fritsche present.

Discussion:

- Just finished third year with Patty Fritsche being the compost site attendant
- ✓ When monitoring not done, were finding items dumped that were not to be at the site

Data prepared by Dave Wilz:

In addition to the options, data presented included year to date monthly summary and compost/yard waste record per month/day.

Option 1

- Continue operation as in 2018 with same hours as 2018
- Patty Fritsche to operate site with assistance from at least two back up replacements
- Direct report to Road Foreman
- Assistance/support from Barb and Janet
- Total estimate cost = \$7,100.00 (includes payroll and related taxes)
- Patty's rate of pay for 2019 is \$12.58

Option 2

- Open and close gates on days and times advertised do not monitor
- Total estimate cost = \$2,100.00 (includes payroll and other related taxes)

Option 3

- Leave site unattended and unlocked (open 24/7/365)
- Total estimated cost \$1,500.00 for waste removal

J Kruziki indicated in the State of the State Address last night, water quality was mentioned and will be looked in to. Over 40% of households across the state receive their water from individual wells.

D Wilz has been found in areas that many individual wells are outside the limits of nitrates.
